**Anatomy of a DUI** (Sgt. Brandon Villanti, WSP; Judge Fowler, Arkansas; Kenny Benfield, North Carolina)

This three-part presentation will illustrate the detection, arrest and prosecution of an impaired driving offender and highlight key elements of building a case. It will explore the use of standardized field sobriety tests (SFSTs) and evidential tests at roadside, highlighting key differences between .08 and .05. Critical steps in toxicology collection and data collection will be described along with effective delivery of court testimony, with a focus on key questions raised by attorneys.
