The Traffic Injury Research Foundation USA, Inc. (TIRF USA) in partnership with the Association of Ignition Interlock Program Administrators (AIIPA), and TIRF Canada collected data on interlock installations in the US in 2020. Previous data collection for installations occurred in 2014, 2015, 2016, 2017, 2018, and 2019. These data provide a comprehensive picture of interlock installations across the US and are a useful benchmark for state ignition interlock program administrators and impaired driving stakeholders to measure interlock usage and growth in interlock programs on an annual basis.
