



MADD calls for Leandra's Law and interlocks to be included in budget session



The Honorable David Paterson Governor, State of New York State Capitol Albany, New York 12224

Dear Governor Paterson,

Mothers Against Drunk Driving (MADD) applauds your leadership in the fight against drunk driving. MADD respectfully requests that you place DWI child endangerment legislation and A7196A/S27B on the calendar for the next special session. A7196A/S27B would require all convicted drunk drivers to use an alcohol ignition interlock device.

All children deserve a designated driver and driving drunk with a child in a vehicle is a form of child abuse. The horrific crash that killed 11 year old Leandra Rosado on October 11, 2009, and injured six other children reinforces the need for a DWI child endangerment law. While 35 other states have special child endangerment laws that impose higher DWI sanctions against individuals who place a child passenger at risk, New York lacks such law.

#### Hit the gas on Leandra's Law, Gov. Paterson tells pols



ALBANY - Gov. Paterson on Thursday formally called on legislators to pass "Leandra's Law" at a special session Tuesday.

Paterson included the measure to toughen penalties for those who drive drunk with passengers under 16 on his formal agenda for the session.

"Gov. Paterson is committed to stricter penalties for drunk drivers with children in the car, which is why he introduced a program bill on this issue on Aug. 13," spokeswoman Marissa Shorenstein said.

Paterson also put on the agenda a bill requiring ignition-interlock devices on cars of anyone convicted of drunken driving.

#### November 10: Compromise reached

MADD agrees to a deal: Mandate interlocks for repeat and first-time offenders with a BAC of .18 or greater and make DWI with a child passenger a felony at .18.

Possibility that interlock is taken out by Senate. MADD CEO issues a lukewarm statement for a joint press release with stakeholders and the Governor that ends the deal:

"MADD supports the Governor's efforts to fight drunk driving in New York. MADD supports felony provisions for DWI child endangerment. MADD also supports the bill requiring interlocks for all convicted drunk drivers. We do have concerns about the limited interlock waiver provision for certain convicted drunk drivers and will carefully monitor its implementation."



#### November 10: Advocacy for reform in Albany

As compromise breaks down, MADD, Lenny Rosado, and others advocate in-person at the Capitol.

Lenny Rosado meets Speaker Silver in-person. Speaker Silver issues the following statement: "I met this afternoon with Leandra's father, Lenny Rosado, and committed to him that we would pass Leandra's Law. I think we owe it to Leandra to do all we can to protect children against drunk drivers."

MADD to Sheldon Silver: Please don't water down 'Leandra's Law' bill

"There's convincing that needs to be done in the Assembly, and that's what MADD has been trying to do," MADD state policy specialist Frank Harris said.

In pushing for the tougher law, MADD has joined with Lenny Rosado, whose 11-year-old daughter Leandra was killed in a drunken-driving accident last month on the Henry Hudson Parkway.

"MADD supports Lenny Rosado, we support making it a felony to drive drunk with a child in a vehicle, and MADD supports Leandra's Law," Harris said.

MADD, Rosado and Fulton Youth for the Future are organizing a rally in front of Silver's offices today.

MADD also wants lawmakers to require installation of ignition interlocks on vehicles belonging to any convicted drunken driver.


"This is about saving lives and preventing future instances of people dying," Harris said.



### Leandra's Law making a difference?

Only 26% of arrested DWI offenders are installing an ignition interlock.


Ignition interlocks have stopped tens of thousands attempts to drive drunk, around 7,000 to 8,000 per year.

From data collected by MADD of interlock vendors from December 2006 to 2020, these devices stopped 111,000 drunk driving attempts (.08 BAC or greater).

From data collected by MADD of interlock vendors from December 2006 to 2020, these devices stopped 550,000 drinking and driving attempts (.02 BAC or greater)




#### New York Interlock Installs (Source: Roth, TIRF)





#### New York Drunk Driving Deaths (NHTSA)



In New York from 2010 to 2020, drunk driving deaths decreased by 20%. Nationally, from 2010 to 2020 drunk driving deaths increased 15%.\*


If only looking from 2010 to 2019, USA drunk driving deaths increased by .59%.
